(15) Description of component:

The water-trap / water-acid-trap is installed directly into the tubing in front of the lead of the gas analyzer. In case the gas treatment process ahead of the gas analyzer (e.g. cooler, hose pump, dust filter, or similar) fails the water-trap / water-acid trap will become active by using its semipermeable SUN-C Membrane® to protect the gas analyzer from damage. The membrane separates gases from condensate and particulate matter. If the membrane is completely filled, the gas flow will be interrupted.

- All conductive and static-dissipative parts must be connected together and earthed.
- Cleaning of the unit must only be carried out with the aid of a damp cloth (danger of static charge/discharge).
- High-charging electric processes can be excluded.
- Filters made of PVDF may only be used/installed in gas group IIB appliances.
- In Zones 21 and 22 the use of PVDF filters are not permitted.
